HET SCHEEPSHUYS

Terms and conditions

The following terms and conditions apply to all our reservations and services, unless expressly agreed otherwise in writing. The Uniform Conditions for the Hotel and Catering Industry also apply to all our reservations and services.

Definitions

1. Service

The provision of accommodation and / or food and / or beverages by Boutique Hotel Het Scheepshuys and / or the availability of (meeting) space, all with the associated facilities activities and services, and all in the broadest sense of the word.

2. Cancellation

- If canceled up to 1 day before the arrival date, no costs will be charged (if canceled before noon).
- If canceled later or if the guest does not show up (no-show), the total costs of the reservation will be charged.

3. Group reservations

Three rooms or more is considered a group reservation. The following applies to cancellation of a group reservation:

- If canceled more than 1 month before the arrival date, no costs will be charged.
- If canceled more than 14 days before the arrival date, 50% of the reservation will be charged.
- If canceled more than 7 days before the arrival date, 75% of the reservation will be charged.
- If canceled less than 7 days before the arrival date, 100% will be charged.

4. Options

Options are granted with a predetermined expiration date. An option that is not converted into an actual reservation by the guest before the expiration date, will be cancelled by the hotel without prior notice.

5. Liability of the hotel

Boutique Hotel Het Scheepshuys is not responsible for damage or loss of goods brought to the hotel by a guest. The guest indemnifies the hotel against claims of guests in this manner. This does not apply in case the damage or loss is due to intentional or gross negligence fault of the hotel.

6. Liability of the guest

The customer and the guest and those accompanying the same are jointly and severally liable for any and all damages that are and/or shall be inflicted on the hospitality business and/or a third party as a direct or indirect result of an imputable failure to comply and/or an unlawful act, including a violation of the internal rules, committed by the customer and/or the guest and/or those accompanying the same as also for damages that are inflicted by an animal and/or a good of which they are the holder or that falls under their supervision.

7. Obligations

Boutique Hotel Het Scheepshuys is entitled, without notice, to terminate the hotel agreement with the guest if a guest or those who accompany, repeatedly violate the house rules or behave in such a way that this may disturb the order, tranquility and operation of the hotel. Boutique Hotel Het Scheepshuys can refuse a guest at any time.

8. Smoking

- Smoking is not allowed inside the hotel. Several ashtrays are provided on the terrace outside.
- A fine of € 100 will be charged for violation.

9. VAT and tourist tax

9% VAT is included in the price. The guest pays € 2.75 tourist tax per night per person. This is not included in the price.

10. Pets

Pets are not allowed. A fine of € 100 will be charged for violation.
